A written test was conducted on dated 07.07.2019 for authorisation of Chartered Electrical Safety Engineers (CESE) under regulation 5A of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Amendment Regulations, 2018 and guidelines issued by the Central Electricity Authority vide notification dated 21.06.2018, in which no candidate has qualified the written test for authorisation of CESE.

Hence, in supersession of this office order No. CEI/172 dated 18.03.2016 and No. CEI/95 dated 28.11.2016 issued by the Chief Electrical Inspector to Govt., Haryana, to facilitate the owner of electrical installation for self certification, the following has been approved by the Government, which shall come into force with immediate effect:-

- 1. The owner may get his electrical installation tested/inspected through his own eligible engineer who fulfills the qualification and experience as per regulation 5A of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Amendment Regulations, 2018 notified vide notification dated 01.03.2018 followed by guidelines issued by the Central Electricity Authority vide notification dated 21.06.2018 till such time sufficient numbers of CESEs are authorised to self certify their electrical installation under regulations 30 and 43 of the Central Electricity Authority (Measures relating to Safety and Electric Supply) Regulations, 2010, as amended from time to time.
- 2. The authorisation of existing Chartered Electrical Safety Engineers will be cancelled with immediate effect.
